## Health and Safety

8.45 In emergency lighting and all emergency equipment connected to a secondary power source?

A re-audit was conducted on 13 & 14 August 2025 Status - New Finding Based on the factory tour, the factory had not provided an emergency light on the back side stairs leading to the ground floor from the first floor. Law Ref: In accordance with UP Factories Rules 1950 Section 61(10) (e), the exits shall be clearly visible and suitably illuminated with a suitable arrangement, whatever artificial lighting is to be adopted for this purpose, to maintain the required illumination in case of failure of the normal source of electric supply. It is recommended that the factory ensure and provide emergency lights on all escape routes and stairs to illuminate the escape outes during an emergency.

8.92 Is use of personal protective equipment (PPE) required and enforced by facility management?

A re-audit was conducted on 13 & 14 August 2025 Status - Open Based on the factory tour, below were noted - 1. 01 out of 01 spotter working without an appropriate mask (a dust mask is used instead of a mask that can be used for chemical work) in the spotting area located on the roof. 2. 02 out of 04 overlock machine operators were not using a dust mask in the stitching area located on the second floor. Law Ref: In accordance with the Factory Act 1948, section 7A(1), every occupier shall ensure, so far as is reasonably practicable, the health, safety, and welfare of all workers while they are at work in the factory. (2) Without prejudice to the generality of the provisions of sub-section (1), the matters to which such duty extends shall include- a) the provision and maintenance of plant and systems of work in the factory that are safe and without risks to health, b) The arrangements in the factory for ensuring safety and absence of risks to health in connection with the use, handling, storage, and transport of articles and substances, c) The provision of such information, instruction, training, and supervision as are necessary to ensure the health and safety of all workers at work. It is recommended that the factory ensure the use of appropriate masks (Personal Protective Equipment) during all working hours. An Initial audit was conducted on 17 & 18 May 2019 During factory tour and management interview it is noted that adequate mask is not provided to spotter working with solvent. In accordance with Factory Act 1948 section 7A(1) every occupier shall ensure, so far as is reasonably practicable, the health, safety and welfare of all workers while they are at work in the factory. (2) Without prejudice to the generality of the provisions of sub-section (1), the matters to which such duty extends, shall include- a) the provision and maintenance of plant and systems of work in the factory that are safe and without risks to health, b) The arrangements in the factory for ensuring safety and absence of risks to health in connection with the use, handing, storage, and transport of articles and substances, c) The provision of such information, instruction, training, and supervision as are necessary to ensure the health and safety of all workers at work.
